store and proceeded to the deli to purchase a sandwich. As Colon was placing his order, an unknown male walked up to Colon and began putting his face near Colon's. Colon stated that the male identified himself as the pregnant female's husband. The unknown male proceeded to push his face into Colon's poking it with his nose. Colon then pushed the unknown male to create distance. The unknown male then continued to advance towards Colon and attempted to put Colon into a headlock. Colon was in fear of being injured and began to fight back. Once the situation began to escalate, on lookers began to separate Colon from the unknown male. Colon stated that the unknown male and pregnant female left the store and drove off in an unknown SUV.

Colon did not give anyone permission to hit him and wishes to prosecute criminally.

I spoke with Donna Bankstahl who witnessed the incident via a department land line telephone. Bankstahl stated the following verbally:

Bankstahl saw a pregnant female loading her child into a vehicle and left the cart in between two parking spaces. Bankstahl heard Colon yelling at the pregnant female to move the cart out of the way and was cursing at her. The pregnant female then called her husband on her cell phone. Bankstahl went over to the parking space to check on the well being of the pregnant female. Colon then began cursing at Bankstahl telling her to `mind your own business`. Colon then went inside of the store. The pregnant female`s husband arrived and Bankstahl left and went inside of the store to purchase an item from the deli. While waiting in line, Bankstahl witnessed the pregnant female`s husband walk into the store towards the deli line where she saw Colon ordering his food. When Bankstahl turned around to get a second look, she saw the pregnant female`s husband and Colon fighting on the ground. Bankstahl left her information with a store manager and left.

Kevin Hallmark stated that he had the fight recorded and posted it to YouTube.com. Hallmark provided the link to the video (http://youtube.com/oDqZhY5dVW4). I attempted to view the video on my department issued MCT but was met with negative results. Hallmark stated that he recorded video of the fight after it was in already progress.

No injuries were reported at the scene and no arrests were made.
