## AFFIDAVIT FOR ARREST WARRANT

## THE STATE OF FLORIDA COUNTY OF ORANGE

**BEFORE ME**, the undersigned Judge, personally appeared your Affiant, Detective Rick Salcedo #4999, a member of the Orlando Police Department, who, by me being first duly sworn, says that on the 9 day of March, 2016, in Orange County, Florida, the Defendant, **SCOTT WESLEY IRWIN**, did in violation of section(s) **810-145**, Florida Statutes, unlawfully did commit the crime(s) of **Video Voyeurism**.

On 2/3/2016, between 1820 hours and 1835 hours, David Gelalia (Hereinafter, "David") witnessed the defendant, later identified as Scott Wesley Irwin inside the Baldwin Park Publix supermarket (1501 Meeting Place) video-recording unsuspecting young girls between the ages of 5-8 under their shorts or skirt. David observed the following:

The defendant was walking in the bacon/hotdog section of the store, carrying a Publix hand basket with what appeared to be a box of Saltine crackers inside. The defendant placed his cell phone inside the basket on top of the box. The defendant lowered the hand basket under the young girls cut off jean shorts as he walked past her. The defendant picked up his phone and looked at it.

The defendant followed another young girl, approximately 6-7 years of age, wearing a black skirt. The defendant approached the girl from behind and lowered the hand basket under her skirt.

David went to the service desk to report what he witnessed. One of the employees started following the defendant. David believes the defendant got scared so the defendant emptied his basket, returned the basket to the holder as he exited the store. The employees and the manager followed the defendant outside and they saw him leaving in a gray truck. As David exited the store, he observed the defendant driving away in a gray Nissan Titan, full-size pick-up truck. They did not report the incident to the police but the manager, later identified as Douglas Warrick (Hereinafter, "Doug") said he would review the store surveillance video.

On 2/24/2016, David was back at the Publix supermarket and was about to checkout when he observed the defendant walk in the store. David placed all of his items back in the shopping cart and followed the defendant to see if he would do it again. The defendant was carrying a hand basket with a box inside. The defendant started following a young girl between the ages of 13-15, wearing a baby blue colored tennis skirt and a white top in the produce section. David went around the other direction to get a better view but by the time he saw the defendant, he had already passed the young girl. The defendant was looking at his phone similar to what he was doing the first time he saw him video recording. David immediately went to the manager, who just happen to be Doug and informed him the suspect was inside the store. David and the manager followed the defendant to his car. Doug obtained a tag number. The defendant was driving the same gray Nissan Titan with a "UCF" sticker on the back window and a University of Florida tag.

Doug reviewed the surveillance footage and saw the defendant carrying a green hand basket with a box of Saltine crackers inside. The defendant placed his cell phone inside the basket and while walking past the young girl, he angles the basket under her skirt. The defendant then placed the basket on the floor directly under the young girl's skirt. Doug contacted law enforcement to report the incident.

Officer Kyle Medvetz #19552 responded to the Publix and met with Doug. Doug described the defendant as a white male in his mid-twenties wearing a red shirt, jeans and a goatee. The defendant was driving a gray Nissan Titan bearing a University of Florida tag "Zee". Officer Medvetz reviewed the surveillance footage and observed the defendant clearly committing video

voyeurism to a young teenager. Utilizing law enforcement databases, Officer Medvetz developed a suspect, Scott Wesley Irwin who resembles the description that David and Doug provided. Officer Medvetz generated a photographic line-up with a photograph of Irwin and five other individuals with similar physical characteristics.

On 2/25/2016 at 2120 hours, Officer H. Bonila #19522 met with David and presented him with the photo line-up. David immediately selected photo #4 and positively identified Scott Wesley Irwin as the same individual he observed videotaping under the young girls skirt.

Your Affiant,, Detective Rick Salcedo #4999 was assigned to this case. I reviewed the surveillance footage from 2/24/2016. Screen shots of the victim who appears to be wearing a tennis skirt and a visor hat was captured.



I went to the address listed in the defendant's driver license. I the same gray Nissan Titan bearing a University of Florida tag "was parked in the driveway.

Based on the witness' testimony and the surveillance footage, your affiant believes the defendant overtly and surreptitiously video recorded or photographed under the skirt of the 13-year-old girl, who had an expectation of privacy. There is probable cause to believe the defendant committed the act of Video Voyeurism.

Due to the above facts, it is your Affiant's belief that the defendant, **SCOTT WESLEY IRWIN**, has committed aforementioned violations of the laws of the State of Florida and that probable cause exists for the issuance of an arrest warrant.
